5. Directors Reports (*Refer to AGM Package*)

Ice Scheduler-Jeremy Wale presented as was dependant on COVID-19 Status

There is no concrete return date for ice in either Barrie or Innisfil. In 2019-2020 we used 9 hours in Barrie and 10 in Innisfil. The ice in Innisfil is more expensive because our association is considered non-resident. There have been discussions about reducing the criteria of 80% resident mix to consider resident, but Innisfil will not alter the mix. Barrie has approved ice for next year but still awaiting information from Innisfil. We are 5th in order of importance for ice as we are non-resident. We are hoping to keep the times we had last year, but there has been no concrete information. Innisfil increased the cost for ice by 3%, but Barrie kept the rates the same. We have investigated getting more ice in Barrie, but there are no reasonable times available.

6. Financial Reports (*Refer to AGM Package for detailed report*) Treasurer- Jeff Wiltshire
At the beginning of the year, Roger was using QuickBooks, but a move was made to Zero. Roger helped immensely with this transition. Registration numbers were down and there was a shift in the composition of the registrations which caused a fall in revenue of around \$5500. The Kiwanis donations as well as 3 \$600 sponsors which were not realized, which also contributed to

the shortfall. COVID has caused a shift and has muddled the accounting because some receivables and payables are carried over to another year. There is a variance of \$2800 from last year in cash flow mainly due to the unrealized sponsorship/donations.

Registrar Report

Registration for this season seemed to be constantly changing and required lots of last minute changes and flexibility. So thank you to our players and families for being patient enough to register multiple times and send many payments.

Due to COVID restrictions we were unable to offer our "Learn to Skate Program" however some of our younger players were able to participate at the U8 level. As you know we made it through our Fall season at the Orange level with modified game at the House League level and Skills & Development Sessions at the Regional and Provincial Level. After the January/February lockdown we manage to get our players back on the ice for Skills Sessions at the Red level before the third wave lockdown ended our season.

Our Fall Registration brought in 145 players under 19 years old, and 26 Open players 19 years old and above for a total of <u>171 registrations</u>. We also had 30 players participate in Regional Skills & Development and 44 players participate in Provincial Skills & Development.

In the coming weeks please watch your email for preregistration for next year. Also for those getting a credit for cancelled Red Level skills time you will be sent a PROMO code closer to the Fall to use when you fully register your player.

The COVID-19 protocols and restrictions required weeks of work over the course of August and September to get approval by Ringette Ontario to start our Orange Level modified game play. This season would have never happened without the huge commitment from Lori Carre, Noa Upham and Jani Edwards – we are grateful to the three of you! We would also like to thank our coaches and bench staff for all their hard work ensuring social distancing, safe practices and game play and sanitization of equipment. Our Team Safety Leads, also played a vital role in managing attendance and ensuring COVID screening tools were completed. Finally a thank you to our parents who worked hard to do their players attendance and COVID Screening, followed the spectator guidelines, waited outside in the cold and were so positive and supportive this year. We are happy to report that we did not have any outbreaks or even close contact COVID positive cases within our organization! Players and families were very transparent and reached out when they were unsure about possible contacts and stayed home if they were the least bit unwell. This worked to keep us on the ice! We expect some elements of COVID-19 safety to remain in place this fall however we are hopeful that the role out of vaccines and the recent

approval of Pfizer for ages 12 and up will let us play more and with fewer restrictions! Like you we can't wait to be going to tournaments, hanging out in hotels and having team dinners.

Referee-in-Chief Report

The 2020/2021 season was a challenging one for all, including the officials. Different COVID19 screening procedures and rule modifications were just some of the things our officials had to deal with. Staying away from players and not touching the ring forced the officials to pay attention to some of the things they typically do subconsciously during the game. This made things a little more difficult than usual, but each of our officials did a great job adapting.

With our fall house league program, the officiating team was able to stay active and continue working on officiating-specific skills. Our officiating team participated in forty-one (41) games prior to Simcoe-Muskoka moving to COVID Red level in December. This translates to eighty-two (82) assignments. In comparison, out of the fourteen associations in the Southern Region, only one other association had games with officials.

Due to the reduced number of games from the cancellation of the Regional and Provincial programs and the uncertainty surrounding COVID19, we were unable to add new first year officials to the team. There were several players interested in joining last season and depending on where we are with COVID19, we hope to be able to add them to the program. I would like to thank Kennedy Upham for taking and passing the Level 1 Officiating Clinic last fall, even when she knew she may not get the chance to officiate during the 2020/2021 season. I look forward to adding Kennedy to our team in 2021.

Though we did not add any new officials last season, we were able to add one fantastic official from Newmarket. Zoe Walters moved to the BDRA area last summer and joined our team in the fall. I would like to welcome Zoe to the program and congratulate her on the great work she did last season.

With the completion of their second season in the officiating program, Eva Hill, Hunter Kett, Greta Kotch, Theo Stanford and Sami Wale are now eligible to attend the Level 2/3 clinic, which is the next stage of the officiating program. All five will have the opportunity to learn more about rules, with a focus on penalties, through the online clinic next fall. This opportunity, combined with their mastery of the Level 1 criteria, will help provide them with the tools needed to officiate at the Regional level. Each official performed extremely well this past season and I cannot wait to see where next year takes them.

In closing, I would like to thank Emma Fowler, Angela Schottroff and Camryn Harrison for stepping up and taking on more senior roles this season. With the cancellation of the competitive programs and the inclusion of those players into the house league program, it made for more challenging games. Each worked with younger officials in the U12 division and officiated games in the very competitive U16 division. We could not have had such a successful season without their leadership.

Treasurer's Report

These summarized financial highlights are for review at the BDRA 2020-21 Annual General Meeting and readers are cautioned that these highlights may not be appropriate for their purposes. For more information on the Association's financial position, and cash flows, reference should be made to the related complete financial statements. Copies of the complete financial statements are available from the executive of the Barrie & District Ringette Association.

The 2020-21 season ended with a gain of \$8,569. This was a challenging year throughout as Covid-19 continued to cause disruptions to planning, and team play. The 2020-21 season started out with a meat fundraiser that raised \$1662. This in addition to mask sales started the year with some positive momentum and club support. It was difficult to work within the parameters of a regular season budget plan with the constant changes made by municipalities and provincial governments with regards to return to play guidelines. As a result, finances decisions were made based on how programs we able to run while aligning with the zones defined for public measures. Each program was analyzed to determine the appropriate income needed to offset the expenses. With the government imposed restrictions, items such as pictures and the yearend banquet were deferred.
